Management and Operation of Bamboo round stick Common Facility Centre

Tripura Bamboo Mission, under the Dept of Industries & commerce, Govt of Tripura is committed for the development of bamboo sector in the state through various interventions starting from bamboo plantation to creation of production infrastructure to promote bamboo industry in the State. It has been working in a cluster development approach since April 2017, and IL&FS Clusters, New Delhi is the implementing partner.

Traditionally, Tripura used to be the biggest producer and supplier of Bamboo stick for the incense industry of India. With change in technology and international trade regime, the incense sector in India has undergone a sea change and the bamboo stick producers of the state have suffered a huge loss. The bamboo stick sector in India needs high investment and latest technology which the Tripura Artisans are not able to afford. The production of bamboo stick has come done drastically over the last few years and a large number of artisans lost their livelihood. On this contest, the Govt of Tripura, through TBM, has set up one Common Facility Centre for bamboo round stick production at Kumarghat, Unakoti district.

The centre is spread in two acre of land in six building of 17,560 sq ft build up area. The facility contains following machines to support the production of the 62.5 mt of round stick per month with one shift operation.

It is expected that the facility will be able to provide job opportunity for 600 bamboo round stick artisans working around Kumarghat Bamboo stick cluster who were earlier involved in bamboo stick production in their house.

TBM is interested to provide this facility to suitable cooperative/society for operation and maintenance of the CFC and providing employment and services to the local bamboo stick artisans in a professional manner based on market driven economics. The operation and management of the facility will be extended for a three years period initially and can be extended further based on the performance of the society/cooperative.

Scope of Work:

The society/cooperative has to make the CFC operational with its own investment towards working capital, maintenance of the machines and support and manage the workforce. If required it can deploy additional machines, tools etc for optimizing the operation. It shall be responsible for

- Procurement of raw material on its own expenses
- Engagement of work force as per the market rate as employ or as work contract
- Marketing/selling the produce
- Arranging working capital for day to day operation and Management
- Engage the required technical manpower for machine operation and Maintenance
- Replace and repair the machines, its spare part etc
- Pay all the tax, fee etc if any applicable for operation like-Electric, water bill
- Follow all the statutory obligations related to operation of the set up including safety and security measures
- Pay the Security deposit/rental charge for the CFC to TBM on monthly basis

Eligible Criteria:

The society/cooperative must fulfil the following criteria for successfully participation in the selection process

- Shall be involved in production and marketing of bamboo stick in India
- Shall have an annual audited turnover of Rs 2.5 Crore during the last three years from the bamboo stick business
- Shall be able to manage and provide services to 600 local artisans involved in bamboo stick making.
- Shall be able to mobilize the working capital of Rs 1.3 crores
- Shall be able to pay a minimum of Rs 4.5 lakhs as Non-refundable security deposit
- Shall be able to pay Rs 1.20 lakhs as monthly fee for the

Terms of Reference

- The cooperative/society shall not be allowed to remove any machine/equipment from the CFC without prior permission of Tripura Bamboo Mission
- It can add/include any machine/equipment etc at the CFC with prior permission of TBM
- It must maintain one asset register at the CFC for all such changes with proper approval of TBM.
- The additional machine/equipment/facility created by the society /cooperative shall be from its own fund
- TBM official shall be allowed to do one monthly/quarterly/annual audit on the available of machines/equipments etc at the facility
- TBM shall not control the functioning of the society/cooperative on day to day basis.
- TBM shall be allowed to organize training/exposure program to the CFC for the other cooperative/society/entrepreneurs/artisans/govt official etc
- The non-refundable deposit must be paid on signing of the agreement
- The monthly fee must be paid on beginning of every month
- Penalty shall be charged for delay in payment of monthly fee
- Any loss/damage/removal of machine from the CFC shall be recovered from the society/cooperative based on the actual cost.
- The machines provided by the TBM shall be maintained by the cooperative/society on its own
- Replacement of spare part shall be responsibility of the cooperative/society on its own expenses.
- The last date for submission of the documents is 31st March 2017, 4.00 P.M.
- All forms must be fill up and submit at TBM office by courier or by post.
- Mere application doesn't quarantee the eligibility of the agency.
- Tripura Bamboo Mission, reserves the right to accept or reject any or all the application without assigning any reason thereof.
